MINUTES OF THE AMERICAN LEGION DEPT OF MINNESOTA 6^{TH} DISTRICT CONVENTION

The 6th District Convention held at Brainerd American Legion Post 255 was called to order on June 1, 2024 by 6th District Commander Anthony Koop at 8:35 am. Brainerd Post 255 Color Guard Posted the Colors. Following the opening prayer by 6th District Chaplain Frank Grittner and posting of the POW-MIA drape, the Pledge of Allegiance and the Preamble to the Constitution of the American Legion were recited. Roll call of officers and chairmen was taken.

Baxter, MN Mayor Darrel Olson, an army veteran welcomed everyone to the area and thanked them for visiting. Other greetings to the Brainerd area and convention were presented by Brainerd Post 255 Commander Rick Wiersgalla, 6th District East Sub Vice Commander and Convention Chairman Dewayne Collins, Department Vice Commander Paul Edwards, Department Membership Director Pam Krill and Department Commander Paul Hassing.

Commander Koop read the appointments to the convention committees. Time & Place is Rick Cross, Vern Massie and Dewayne Collins. Credential's is Dave Doubrava, Veronica Fernlund, Judi Ficek. Resolutions is Lloyd Ricker, Carl Moon, Mel Beussler

Motion was made and seconded (Frank Grittner-Paul Edwards) to approve the Convention Rules as printed in the back of the Book of Annual Reports. Carried.

Motion was made and seconded (Jim Lucas-Frank Grittner) to dispense with the reading of the June 3, 2023, 6th Convention Minutes. Carried.

Roll call of Posts was taken by Adjutant Tom Fernlund. There were 21 Posts present.

Vice Commander Reports; South Sub Vice Commander Frank Grittner recognized current and past 6th District Officers and Chairman who died this past year, Jim Blakesley, Wayne Gilbertson and Ken Meyer. Frank also said membership is going well, his area is at 100.54%. East Sub Vice Commander Dewayne Collins gave a membership update for his area.

Guest Danny Schmidt, chairman for the Bemidji Softball Committee hosting the 2024 Department Girls Fastpitch State Tournament, requested financial help for the tournament. The host city is responsible for housing the players and a banquet along with other expenses.

Judge Advocate read the (2) proposed resolutions presented to the 6th District Convention.

Children and Youth Chairman Karen O'Bar announced the Posts receiving Children & Youth Awards: (Membership 15-99) Big Lake, (Membership 100-299) Hillman, (Membership 300-499) Walker, (Membership

500+) Brainerd. Certificates for participation were presented to Browerville, Bertha, Rice, Melrose, Waite Park and Little Falls Posts.

Membership Chairman Jim Lucas said the District is 147 from goal, currently 98.55%. He also said the District is in 1st place for the Premier race. Jim announced the Posts of the Year, St. Augusta Post 621 (small posts) and Little Falls Post 46 (large posts).

Department Auxiliary President Sharon Cross gave greetings and thanked everyone for all their support this year.

2022-2023 6th District Membership Chairman Dr. Carl Moon presented 2022-2023 membership awards. Carl was in the hospital for part of last year.

Jim Lucas presented the 6th District Legionnaire of the Year award to Dave Doubrava.

Veronica Fernlund provided the 1st credentials report. There are 21 Posts with a voting strength of 87 and 52 Legionnaires registered.

Motion was made and seconded (Tom Skuza-Karen O'Bar) to approve the finance report provided by Finance Officer Gene Hesse. Carried.

Motion was made and seconded (Paul Edwards-Rick Cross) to approve a 6th District dues increase of .75 cents to begin with the 2025 membership year. Carried.

Motion was made and seconded (Dave Doubrava-Rick Cross) to approve the recommendation by the Resolutions Committee to disapprove resolutions #1 and #2. Carried.

Legionville President Dr. Carl Moon provided a report on the upcoming camp season at Legionville. He said donations are needed. (See Attached Report)

Blood Chairman Judi Ficek said her report is published in the Annual Book of Reports. Judi presented certificates to Posts that submitted their Blood program reports.

Girls Fastpitch Softball Chairman Tom Fernlund provided a report on the upcoming season and State Tournament

Oratorical Chairman Jim Lucas said the winner of this year's contest was Elijah Cox sponsored by Walker Post 134. Elijah also won the Department Oratorical contest. Murray Bright reported on how Walker Post 134 recruits students to participate in the contest.

Commander Koop recessed the 6th District Convention at 10:30 am so everyone could attend the Memorial Service and Gold Star Banquet.

Commander Koop called the 6th District Convention back to order at 1:30 pm.

Roll call of Posts was taken by Adjutant Tom Fernlund. There were 20 Posts present.

Time & Place Committee reported Brainerd Post 255 was the only Post to bid for the 2025 6th District Convention and (2) Posts bid for the 2025 Mid-Winter Conference, Nisswa Post 627 and Melrose Post 101.

Motion was made and seconded (Paul Edwards-Jim Lucas) to approve Brainerd Post 255 as host of the 2025 6th District Convention. Carried.

Motion was made and seconded (Carl Moon-Paul Edwards) to approve Melrose Post 101 as host of the 2025 Mid-Winter Conference. Carried

Motion was made and seconded (Rick Cross-Karen O'Bar) to approve Menahga Post 448's request to turn-in their American Legion Post Charter. Carried

Motion was made and seconded (Lloyd Ricker-Frank Grittner) for the 6th District to endorse Dr. Carl Moon for 2024-2025 Department Commander. Carried

Motion was made and seconded (Lloyd Ricker-Dave Doubrava) for the 6th District to endorse Veronica Fernlund for 2024-2025 Department Vice Commander. Carried

Motion was made and seconded (Frank Grittner-Paul Edwards) for the 6th District to endorse Karen O'Bar for 2024-2025 Department Historian. Carried

Motion made and seconded (Paul Edwards-Karen O'Bar) for nominations for 2024-2025 6th District Officers were made. Those nominated were: Frank Grittner for Commander, Gene Hesse for Finance Officer, Jason Pierce for Chaplain, Veronica Fernlund for Historian and Tom Skuza for Sgt at Arms. Carried

Motion was made and seconded (Paul Edwards-Jeff Thompson) to cast a unanimous ballot to elect Frank Grittner 2024-2025 6th District Commander. Carried

Motion was made and seconded (Paul Edwards-Dave Doubrava) to cast a unanimous ballot to elect Gene Hesse 2024-2025 6th District Finance Officer, Jason Pierce for 2024-2025 6th District Chaplain, Veronica Fernlund for 2024-2025 6th District Historian, Tom Skuza for 2024-2025 6th District Sgt-at-Arms Carried

Commander Koop recessed the convention for 20 minutes for the sub-districts to caucus.

Motion was made and seconded (Paul Edwards-Jim Lucas) to approve the 2024-2025 6th District Vice Commanders and County Council Commanders elected by their Sub Districts. Carried (See attached for list of officers.)

Motion was made and seconded (Paul Edwards-Carl Moon) to approve the Delegates to the 2024 National Convention elected by their Sub-Districts. Carried (See attached for list of delegates)

Roll Call vote of Posts was taken to elect (1) At-Large Delegate to National Convention due to the North-Sub not having a delegate. Tom Fernlund was elected as Delegate-At Large and Alternates in order were Karen O'Bar, Veronica Fernlund.

Detachment of MN SAL Commander John Weis addressed the convention. John announced the Detachment Convention is scheduled for June 28-29, 2024 in Forest Lake.

Dr. Carl Moon installed the newly elected officers.

Newly elected Commander Frank Grittner thanked everyone for coming. The POW-MIA drape was removed from the chair. Chaplain Jason Pierce gave closing prayer. Sgt-at-Arms Tom Skuza retired the colors in place and closed the meeting at 3:45 pm.

As of the 22 May membership bulletin:

Overall, the Deep South is still in 1st place in the district at 95.58%, needing 166 for 100%. Benton/Sherburne County Council is at 99.92%, West Stearns at 95.45%, and East Stearns is at 92.33%. As to individual posts:

Eight are over 100%, Elk River, Big Lake, Becker, Foley, Clear Lake, Zimmerman, St. Stephen, and Sauk Centre!

Four are over 95%, St. Cloud, Holdingford, Sartell, and Richmond.

All Benton/Sherburne posts are over 91.95%, East Stearns has two posts below 90%. West Stearns has one below 90%. Note that I'm not calling out individual posts. They should know who they are, and all info is in the weekly membership bulletin for all to see.

All three county councils are all active. West Stearns is picking up some momentum. Scott Kowski, Sauk Centre Post 67 has been elected as WSCC commander. Bud Stimmler, Clear Lake Post 354, is retiring after several years as BSCC commander. Bill Hannay, Big Lake Post 147, was elected to replace him. Congratulations Scott and Bill, and thank you Bud. Dave Wells was re-elected ESCC commander.

I posed a rhetorical question to all the south posts in my last news bit to them: Who is the most important member of your post?

In my opinion, for what little that's worth, the last NEW member you signed up is the most important post member. And, for what little my opinions are worth, it's my opinion too, that that last new member should somehow be recognized as such. And then the next newest member be recognized, and the next, and so on. For some of those new members, it might be the only recognition from the post they'll ever receive, but it could leave a lasting memory. And, over time, you'll build an environment of appreciative members being recognized for more than just becoming another number.

Curious as to how many posts put out periodic newsletters. That's a great way to recognize individual members for whatever. It's not only for upcoming meetings and other event dates. It is interesting to note that there are only eight post newsletters posted on the district website, five of those from south sub-district posts. Not all are current though, one is from 2023. That free posting is a great way to let neighboring posts know what your post is doing.

BOYS STATE

<u>District Chairman's report for District Convention of 2025</u>

The 2025 Boys State leadership adventure (Boys State) is scheduled for June 8-114, 2025, at St. John's University. The cost this year is \$350 per delegate, which is payable from gambling funds. This year, the total anticipated attendance at Boys State throughout the nation is expected to be about 10,000 candidates; the participation rate in Minnesota is anticipated to be about 175 candidates. District 6 is contributing 28 candidates, which is fewer than the 34 candidates of last year. It appears to me that a significant cause for the reduction in participation this year is conflict with high school spring sports. Personally, there were 12 boys that I had recruited which ultimately dropped out due to sports conflicts. This is consistent with reports I received from several posts. I suspect that this is a topic that has been addressed several times; nevertheless, it deserves another look.

The boys who were selected to go on to Boys Nation from the 2024 program were Tucker Fournier (sponsored by Osseo-Maple Grove Post 172), and Lonne Gilbert (sponsored by Watertown Post 121).

I leave you with this: In the years that I have been involved in recruiting young men for the Boys State program, there have been several occasions that I have had a mother seek me out after her son returned, profusely thanking me for the positive changes she saw in her son. Other Posts have commented on the fact that returning candidates commonly talk about their "life-changing" experience. Sending boys to Boys State should be at a high priority for each of our posts.

Resolutions to be considered and voted on at the 6th District Convention

A Resolution to clarify and restate the intent of Article II, Section 2 of the National American Legion Constitution and By-Laws. Written by Paul Edwards, Post Commander, Nisswa, MN

WHEREAS, the charter of the American Legion states under § 21706. Political activities, "The corporation shall be nonpolitical and may not promote the candidacy of an individual seeking public office", and

WHEREAS, Article II, Nature, Section 2 states, "The American Legion shall be absolutely nonpolitical and shall not be used for the dissemination of partisan principles nor for the promotion of the candidacy of any person seeking public office or preferment", and

WHEREAS, The American Legion uses political methods in support of its legislative agenda and priorities to support the four pillars of the American Legion, and

WHEREAS, The American Legion has Legislative Committees and Chairs at the national, department and district levels whose function it is to use political methods to work with federal and state legislators to support The American Legion's policies, legislative agenda, and programs, and

WHEREAS, many Legionnaires interpret Article II, Section 2 to mean that Legionnaires are forbidden to hold or express a political opinion on any topic, and

WHEREAS, the definition and interpretation of the word "political" has changed since the Constitution was first written, now therefore be it

RESOLVED, by the members of Post 627 of Nisswa, Minnesota in regular meeting assembled that Article II, Section 2 of the National Constitution be changed from, "The American Legion shall be absolutely nonpolitical and shall not be used for the dissemination of partisan principles nor for the promotion of the candidacy of any person seeking public office or preferment." To read "The American Legion shall use political tools and methods in pursuit of legislative action to support the furtherance of its legislative priorities and agendas but shall be absolutely nonpartisan and shall not be used for the dissemination of partisan principles nor for the promotion of the candidacy of any person seeking public office or preferment" and be it further

RESOLVED, that this resolution be forwarded to the 6th District Adjutant for presentation to the District 6th District Convention convened at Brainerd, MN on June 6-7, 2025, for consideration and approval and be it further

RESOLVED, that on approval this resolution be presented for consideration to the Department of Minnesota Convention to be convened at Wilmar, Minnesota on July 10 - 12, 2025, and be it finally **RESOLVED,** that upon approval this resolution be forwarded to the National Adjutant for presentation and consideration at the 2025 National Convention in Tampa Bay, Florida August 22 - 28, 2025.

LIST OF RECOMMENDATIONS FOR HOSTING DISTRICT CONVENTIONS

Note: This list does not replace the Constitution and Bylaws of the Sixth District American Legion, Article 12 – Time and Place; but to be used in conjunction with and as further clarification of that document.

- 1. The request to host a District Convention must be made by the Post Adjutant, in writing to the Time & Place Chair, showing approval of the membership at a Post meeting. It must state the date and year requested and be presented 30 days prior to the preceding District Convention for review by the Time and Place Committee at Convention.
- 2. The District Convention is to be held on Friday and Saturday only and to be held on or as close to the first weekend in June. However, the second weekend of June may be acceptable. The Convention for all delegates will be held on Saturday only.
- 3. Housing should be available in the area Friday night. Twenty-five (25) rooms minimum shall be "blocked" up to 30 days prior to the Convention.
- 4. Consideration should be given to having bus or shuttle service.
- 5. There must be adequate meeting places for the Legion, Auxiliary, S.A.L. and Legion Riders.
 - a. Minimum seating of 75 for the Legion.
 - b. Minimum seating of 75 for the Auxiliary.
 - c. Minimum seating of 10 for the S.A.L.
 - d. Minimum seating of 10 for the Legion Riders.
 - e. Breakout meeting rooms for smaller committees of the Legion and Auxiliary are also required.
 - f. An adequate PA system should be available for Legion, Auxiliary and joint meetings.

- 6. Host Post shall ensure meeting rooms have adequate heating and air conditioning as needed. Host Post must provide a Past Commander's Dinner for up to 50 people on Friday evening, including a "wet bar'. The dinner may be held at the Legion Post Home or at a local supper club. Drink tickets will be supplied by the District Finance Officer. The immediate Past District Commander will notify all Past District Commanders and organize the dinner program. The total cost is to be paid by the District.
- 7. Host Post shall provide a site for the Memorial Service on Saturday to seat up to 175 people. This will be a service remembering the deceased Legion family members with the individual names read by Post number. The Legion family members in attendance will stand as the names of their Legion family are read. Names will be printed and will be part of the Memorial Service Program. This Program will be provided by the District Chaplain in coordination with the Auxiliary and SAL Chaplains and paid for by the District.
- 8. Host Post will provide a location for the Gold Star Family luncheon at noon on Saturday with seating for up to 175 people. The purpose of the Gold Star luncheon is to honor the parents of those service personnel who gave the supreme sacrifice. Host Post will set the price of the luncheon, however it is recommended to be no more than \$20.00. Host Post will provide recommendations for a guest speaker for the Gold Star Family luncheon and is responsible for the cost of the speaker. The speaker shall be approved in advance by the District Commander. Host Post is responsible if housing is required for the guest speaker if needed. It is suggested that the Host Post and all Posts within the District promote getting Gold Star Family Parents to attend this luncheon. The Host Post is responsible for the cost of these meals, but it is suggested that the sponsoring Post pay. Hosting Post shall be notified by sponsoring Post Gold Star Families attending.
- 9. Host Post will provide paid housing for the District Commander and District President for Friday night only.
- 10. Host Post will provide for pre-registration and onsite registration at the convention and retained by the Host Post. It is recommended that the charge be no more than \$20.00.
- 11. The program, agenda and Past Commanders/Presidents list will be provided by the District Commander and President. The Host Post will provide a program or booklet to include the supplied information. The Host Post has the option of selling advertising to other Posts and private businesses. The proceeds from this advertising are retained by the Host Post to cover costs and for added income.
- 12. The District Commander will be responsible for providing pictures of the past District Commanders who have gone to Post Everlasting during the past year. The picture/pictures will be displayed near the podium throughout the convention on the convention floor, with due respect and reverence.

Voting Rules for Convention

ADDDUM C

District Convention Rules:

The following are the standing Convention rules adopted by the Sixth District American Legion Convention held at Sauk Rapids, Minnesota, on May 30, 31, June 1, 2008.

1. With the following modifications, Robert's Rule of Order, Revised, is adopted for this convention.

- 2. (a) That the speech of any delegate recognized by the District Commander or acting Chairman shall be limited to 3 (three) minutes and no more, and that each speaker must identify themselves by name and post.
 - 2. (b)Where a motion is made to table a resolution, the sponsor shall be entitled to speak to the convention floor for 3 (three) minutes on the subject. 3 (three) minutes shall be granted for a rebuttal to the maker of the motion to table before the motion is put.
- 3. That the floor be permitted but once to any individual on any one subject except with the unanimous approval of the Convention.
- 4. That when the poll of any post delegation is demanded by the delegate of any post, the secretary of the convention shall poll the vote of that delegation by delegates without debate or discussion.
- 5. That, on roll call, the chairman or acting chairman of each delegation shall announce the vote of his/her delegation.
- 6. Persons, not duly accredited, shall not participate directly or indirectly in debate on any subject before the Convention. But Past District Commanders shall have the privilege of speaking from the floor but are not allowed to vote unless they are also delegates.
- 7. That no delegate be permitted on the convention floor unless he/she is certified by his/her post as a delegate or alternate, and that each delegate or alternate is duly accredited. To be duly accredited, he/she must be registered.
- 8. No delegate shall act by proxy for his/her post. No post shall vote unless there is at least one duly accredited delegate or alternate on the convention floor.
- 9. Voting shall be by acclamation except when a roll call is demanded by the Chairman or acting chairman of at least three Post Delegations, and except in the election of the District Officers, which shall be by roll call, providing there is more than one candidate running for that office.
- 10. Any guests who are not on the official program as speakers shall be introduced by the District Commander or acting chairman and shall be limited to an address of no more that 3 (three) minutes.
- 11. No intoxicating liquors shall be sold or 'sampled' in the building of the convention meeting unless authorized by the Convention Corporation.
- 12. No elected political office holder shall be permitted to speak during the convention except the Chief Executive Officer of the state of Minnesota and the Chief Executive Officer of the convention city or their representatives and such person as on the printed and published program.
- 13. The Credentials Committee shall be responsible for securing from the Registration Committee a list of the posts which have registered at least one accredited delegate or alternate to the convention. The Credentials Committee shall have the responsibility to update this list as additional posts register.
- 14. That all resolutions, with the exception of those submitted to the Resolutions Committee at least thirty days prior to the Convention, must be presented in writing and referred to the Resolutions Committee for consideration to be brought up on the

- floor. This must be done prior to the Resolutions Committee meeting at the Annual Convention.
- 15. Nominations for District Officers shall be made from the floor.
- 16. Nominating speeches for District Officers shall be limited to 3 (three) minutes. No seconding speeches shall be made.
- 17. In the event more than 2 (two) candidates are nominated for any office, the balloting shall continue until one candidate shall have received a majority of the votes cast.
- 18. The order of business of the Convention shall be in accordance with the printed program except that the District Commander or acting Chairman may deviate from the program in case of emergency.

ADDENDUM D

6th District Voting Procedure

Each year at our District Convention, there is confusion on the voting procedure when there are multiple candidates for offices or delegates to the National Convention. Here are the rules.

I will be using a post example that has 6 votes in the examples.

- 1. The maximum number of votes any one candidate can get is the voting strength of the post. The post does not have to exercise its complete vote. (The post could cast 6 votes but they could cast from 0-6 for a candidate)
- 2. If a post decides to split its votes, the total votes cast cannot exceed the voting strength times the number of those to be elected. (Let's say we elect 2 but have 4 candidates. The total votes that could be cast would be is 12 with no candidate receiving more than 6. Here are some combinations that could be used 6-6-0-0 6-0-0-0 6-2-2-2 6-3-3-0 3-3-3-3, etc These are just some of the combinations.)
- 3. No 'half' votes allowed.
